1. Introduction

- 1.1 This report has been undertaken following the death in December 2014 of Ben during a domestic incident involving his partner Alison at their home address in St Helens Merseyside.
- 1.2 In December 2014, Merseyside Police were informed by the Ambulance Service Control about a reported stabbing at the couple's home address where it was discovered that Ben had received a single stab wound to the right-hand side of his back just below the shoulder. Ben was taken to Whiston Hospital where he underwent surgery, but despite this later that morning Ben died of the injuries.
- 1.3 Alison was arrested at the scene and later charged with the murder of Ben. Alison pleaded not guilty to the murder of Ben but following a trial at Liverpool Crown Court in June 2015 Alison was found guilty of murder and sentenced on 6th July, 2015 to life imprisonment with a minimum tariff of 14 years.
- 1.4 On 22nd December 2014 a Domestic Homicide Review (DHR) was commissioned by St Helens Community Safety Partnership in line with expectations contained within Multi-Agency Statutory Guidance for the Conduct of DHR's 2011 and as amended in 2013.
- 1.5 Following the first meeting of the DHR Panel held on 26th March 2015 all evidence was secured, and chronologies of agency engagement with the two people involved in this Review and their families were commenced.

- 1.6 At this first meeting the Panel also considered if there were any lessons consistent with the purpose of a DHR which needed to be acted upon immediately. None were found at this stage.
- 1.7 This Review was running in parallel with an ongoing criminal investigation and at the request of the Senior Investigating Officer (SIO) in this case at this time no Independent Management Reviews (IMR) were commenced by members of the DHR Panel nor members of Alison or Ben's family or friends interviewed due to their involvement with the criminal justice proceedings.
- 1.8 The request to delay completion of IMR's which may have involved the questioning of staff who had engaged with the family and interviewing of family and friends, was made in order to avoid issues of disclosure associated with the criminal trial.
- 1.9 The work of the DHR was further delayed by the need to appoint a new Chair for the Panel. It was established that the current Chair, Michael Murray, had been involved in the supervision of staff engaged in the investigation of earlier incidents of domestic abuse involving Alison and her children and in order to maintain the independence of the Chair he stood down.
- 1.10 Following the appointment of a new Chair IMR's were completed, interviews with family and friends were commenced by the Chair of the Panel, and the DHR was concluded without further delay.
- 1.11 In accordance with the statutory guidance for the conduct of DHR's, the Panel agreed that the purpose of this DHR was to:
 - Establish what lessons are to be learned from the domestic homicide regarding the way in which local professionals and organisations worked individually and together to safeguard victims.
 - Identify clearly what those lessons are both within and between agencies, how and within what timescales they will be acted upon, and what is expected to change as a result.
 - Apply those lessons to service responses including changes to policies and procedures as appropriate.
 - Prevent domestic violence and abuse homicide and improve service responses for all domestic violence and abuse victims and their children through improved intra and interagency working.

- 1.13 Expert guidance on issues of domestic abuse was provided to the Panel by Wendy Wright St Helens Council Domestic Violence Coordinator and coordinator of the MARAC (Multi Agency Risk Assessment Conference).

Voluntary Sector organisations were represented on the Panel by Debbie Fairhurst, of the Chrysalis Centre for Change a voluntary sector organisation that provides outreach and counselling services within the community and through their domestic abuse support worker host a domestic abuse support group.

Due to changes within organisational structures there were a number of changes to Panel Membership during the lifetime of this Review and the above list of Panel members represents all who sat on the Panel during the lifetime of the Review.

1.13 The Panel met a total of five times during the course of this Review with meetings held on the following dates;

26th March 2015 Chaired by Michael Murray
15th June 2015 Chaired by Michael Murray
22nd October 2015 Chaired by Stephen Mc.Gilvray
17th December 2015 Chaired by Stephen Mc.Gilvray
16th February 2016 Chaired by Stephen Mc.Gilvray

All of the agencies with the exception of the National Probation Service completed an Independent Management Review (IMR). Each IMR detailed;

- o Agencies involvement with Alison and Ben.
- o In some cases, authors of the IMR conducted interviews with staff who had contact with Alison and Ben.
- o Subsequent to the death of Ben any lessons which may be learnt by that agency to prevent such an event from taking place in the future.

Chair of the Domestic Homicide Review Panel.

- 1.16 Initially an independent person Michael Murray was appointed to Chair the Review and Michael chaired the first two meetings of the DHR Panel.
- Michael Murray is a retired police officer who was independent of all agencies and individuals connected to this case. During his police career he was primarily involved in detective duties and performed the role of Senior Investigating Officer on many occasions, specialising in serious crimes committed within families, including a number of Domestic Homicides. During the last years of service, he was in charge of a large Family Crime Investigation Unit, specialising in Child Protection, Domestic Abuse, and the protection of Vulnerable Adults. He was involved in a number of Serious Case Reviews and other Multi Agency reviews. On retirement, he received a national award in relation to a lifetime achievement in policing, recognising his contribution to work and expertise within family based crime. After retirement, he worked as a manager at Women's Aid, and as a strategic consultant to his Local Authority advising on service delivery to victims of domestic abuse. He has received national and local training in relation to the management of DHRs, and is currently involved in a number of DHRs. Michael Murray is not employed by any of the agencies of the St Helens Community Safety Partnership or the Adult Safeguarding Board.
- 1.18 However, following a decision by the Panel to extend the period subject to review it was established that during this period under review Michael had been the supervisor of staff involved in the investigation of a domestic dispute involving Alison and an earlier partner.

- 1.19 St Helens Community Safety Partnership sought advice from the Home Office DHR Enquiries Team and in order to ensure the independence of the Chair Michael Murray stood down from that role and St Helens Community Safety Partnership then commissioned Stephen Mc.Gilvray to Chair the Review Panel and he was appointed in September 2015. Stephen Mc.Gilvray has also written this overview report.
- 1.20 Stephen McGilvray is a former Head of Community Safety in a different Local Authority where he worked for nine years and included within his area of management responsibility within that Authority was the Family Safety Unit, a multi-agency co-located team of professionals focussed on providing support to victims of domestic abuse and their families. This role included responsibility for the coordination and commissioning of Domestic Abuse services to meet the needs of domestic abuse victims and their children. During the period, the Family Safety Unit was under Stephens management the team achieved CAADA Leading Lights accreditation.
- 1.21 Whilst Head of Community Safety Stephen also had management responsibility for the Integrated Offender Management Unit a multi-agency collocated team of Police, Probation, and Substance Misuse workers whose role was to reduce the level of threat and risk posed by offenders, including perpetrators of domestic abuse.
- 1.22 Prior to this Stephen had completed 30 years Police service. Stephen has successfully completed the Home Office training course for Chairs of DHR's. He was responsible for the development of a reciprocal agreement with a neighbouring Authority in relation to the Chair and writing of reports following the work of DHR Panels and has completed several Overview Reports as well as taking part in a number of Serious Case Reviews.
- 1.23 Prior to undertaking this Review Stephen Mc.Gilvray has not had any involvement with the individual people subject to this Review, nor is he employed by any of the participating agencies.
- 1.24 The specific methodology and scope of the review agreed by the Panel at its first meeting in March 2015 included the following:

Seek to establish whether the events which lead to the death of Ben in 2014 could have been predicted or prevented.

Consider the period between 2003 and the date of Ben's death in 2014, subject to any information emerging that prompts a review of any earlier incidents or events that are relevant. Any information outside this timescale relating to domestic abuse within the relevant family

history was considered. The decision made by the Panel to review incidents between 2003 – 2014 was made on the grounds that Alison had during that period been involved in three separate relationships all of which involved incidents of domestic abuse and violence.

The Panel sought the involvement of the family, neighbours and friends of Ben to provide a robust analysis of the events. Interviews did take place with the family of Ben and whilst letters were sent to the friends and neighbours of Ben together with a copy of the Home Office DHR leaflet for friends they did not take up the offer to contribute to this Review.

- 1.24 The Panel also took account of the Coroner's inquest in terms of timing and contact with the family
- 1.25 At the conclusion of its work the Panel produced a report which summarises the chronology of the events, including the actions of involved agencies. (A full chronology of agency and voluntary sector involvement is attached hereto at Appendix B.) The report analyses and comments upon the actions taken by agencies and concludes by making recommendations regarding safeguarding of families where domestic abuse is a feature. The recommendations and those of individual agencies detailed within their IMR's together form an action plan which is included at Appendix A of this report.
- 1.26 Merseyside Police undertook to advise the Panel if there was any conflict between the work of the DHR Review and the criminal justice process. It was agreed that in the case of conflict between the parallel processes the Review would be suspended to await the conclusion of the criminal justice process.
- 1.27 The Panel agreed to produce the report shortly after the conclusion of the criminal justice process subject to responding sensitively to the concerns of the family, particularly in relation to the inquest process, the internal management reviews being completed and the potential for identifying matters which may require further review.

Key lines of enquiry

- 1.28 The Panel agreed that the DHR should be focused upon the following key lines of enquiry:
 - A. How did your agency deal with reports of and/or knowledge of incidents of domestic abuse within the family?

Were responses appropriate and in accordance with agency policy in relation to tackling domestic abuse.

In particular were matters relating to an alleged offender managed effectively and robustly: were responses to alleged victims sympathetic, supportive and timely?

B. Were there opportunities for agencies to identify and assess domestic abuse risk?

What was the Agency responses to any identification of domestic abuse issues?

C. Was communication and information sharing between agencies timely and effective?

Did it lead to a clear understanding of the complexity of the issues within the family and was the approach to helping the family properly coordinated?

Were plans formulated holistic with a long-term problem solving approach rather than being incident driven?

How effective was joint action managed and delivered through the MARAC process. Were resources/capacity an issue in relation to service delivery?

D. Did professionals display appropriate understanding of the risks presented within this family.

Were the risks effectively managed and was supervision and management adequate in providing control and direction.

E. How did your agency recognise and deal with root causes which contributed to the manifestation of domestic abuse within the relationship? (For example alcohol/drug abuse).

Was action/support effective?

If barriers prevented engagement in support what strategies were in place to overcome such barriers?

F. What knowledge did family/friends have of issues within the relationship regarding domestic abuse?

Were they engaged in support strategies and/or did they feel able to be involved?

How will family/friends be encouraged to contribute to the review?

1.29 The author of this report is grateful for the valuable contribution to this report made by the family of Ben. In very difficult and painful circumstances they willingly gave their time and views to Stephen Mc.Gilvray and the information they provided and their views have been included in this report.

2.0 Equality and Diversity

- 2.1 Equality and diversity issues were considered throughout the work of this Review. It was the desire and practice of the Panel that all family members interviewed as part of the Review were treated with respect and dignity.
- 2.2 During the work of the Panel no challenges had to be made by the Chair to agencies for a breach of equality standards.
- 2.3 No issues associated with disability, gender reassignment, marriage and civil partnership, pregnancy and maternity, race, religion and belief, sex and sexual orientation were identified in any of the IMR's.
- 2.4 Alison and Ben subject of this DHR were partners. Both are white British adults with English as their first language.
- 2.6 The ongoing monitoring of the MARAC by Safe Lives illustrates that St Helens MARAC addresses the needs of members of diverse communities details of which are included within the table below
- 2.7 The following table illustrates the breakdown of St Helens MARAC clients during the period 1st January 31st December 2014.

3.0 Ben Family and Friends input.

- 3.1 Family and friends of Ben were witnesses in the criminal trial and at the request of the Police Senior Investigating Officer (SIO) in this case, after advising Bens next of kin of the commencement and purpose of the DHR and enclosing the Home Office leaflet for Family Members no further contact was made with family until the conclusion of the criminal case on 6th July 2015.
- 3.2 In September 2015 Stephen Mc.Gilvray met with the family of Ben, who were supported by an officer from Victim Support throughout the interview. References relating to the family of Ben contained later within this report are as follows;

Erica Mother of Ben

Frances Sister of Ben

It was the decision of the Community Safety Partnership that Ben's family should not be shown a copy of the Overview Report until authorisation for publication had first been received from the Home Office Quality Assurance Unit.

Friends of Ben identified by family members at this time were written to by the Chair of the Review and a Home Office leaflet was enclosed. The letters to friends did not receive any response and they were followed up by telephone calls to the friends made by the Chair, however the friends declined to take part in the Review.

4.0 Structures within St Helens Domestic Abuse Partnerships

- 4.1 Throughout this report several references will be made to MARAC and DVIC. For ease of future reference a summary of each meetings Membership and terms of reference will now be included.
- 4.2 DVIC. This is the Domestic Violence Involving Children meeting which has a membership of;
- St Helens Council
 - St Helens CCG
 - Merseyside Police, (St Helens Domestic Violence Unit)
- 4.3 The meetings were established in 2004 and continue to operate to-day. Terms of Reference for the meeting were created in 2004 and remain in operation to-day.
- 4.4 The Domestic Violence Social Worker chairs this multi-agency meeting that takes place every two weeks to discuss children's welfare following the Police attendance at a domestic incident. The purpose of this meeting is to identify the most appropriate agency to make contact with the victim to offer advice and guidance in relation to their difficulties in cases where the level of abuse falls short of thresholds for children's safeguarding and MARAC. Currently if the contact is not progressed to referral the outcome is recorded on the Children's Services electronic information system under Provide Advice and Information. The introduction of the Early Help Service and the appointment of a Partnership Coordinator has strengthened the response at level 2. Those children and families considered to require further support at level 2 are progressed via the Partnership Coordinator with additional support via bespoke programmes for the victim and the Childnd the allocation of a Family Intervention Worker. When the threshold for intervention is considered to have been met the contact is progressed to referral and a statutory assessment generated.
- 4.5 At the two weekly DVIC meeting it will be decided which agency should undertake the key role in each case. That agency will allocate a key worker who will be responsible for ensuring that the appropriate support or service is provided and that clear outcomes and expectations of the worker will be outlined at the meeting. Feedback on progress will be recorded at the DVIC meeting within four weeks from the date of allocation.
- 4.6 MARAC: Multi-Agency Risk Assessment Conferences are meetings where information about high risk domestic abuse victims (those at risk of murder or serious harm) is shared between local agencies. By bringing all agencies

together at a MARAC, a risk focused, coordinated safety plan can be drawn up to support the victim.

- 4.7 Membership of this meeting includes;
 - Housing Advice Team
 - Helena Housing, Managers of the IDVA Service
 - Midwifery Unit at Whiston Hospital
 - Whiston Hospital Accident and Emergency Department
 - Youth Offending Team
 - Addaction (Substance misuse treatment service)
 - Merseyside Police
 - Registered Social Landlords
 - Merseyside Fire and Rescue Service
 - Adult Mental Health Services
 - Homeless Housing Provider
 - CCG Children Safeguarding officers
 - Victim Support
 - St Helens Council Domestic Violence Coordinator.
- 4.8 The MARAC began operation in St Helens in 2007 and the meetings have a published Procedures, Protocols and supporting documents manual which was updated in June 2014. The MARAC meetings are held every two weeks and is chaired by the Police Inspector within the FCIU.
- 5.1 Domestic Abuse Training within St Helens Partnership.
- 5.2 St Helens and Knowsley Teaching Hospitals NHS Trust has training needs analyses in place in respect of safeguarding Adults, Children and Domestic Abuse Training which date from 2008 in respect of adults, 2011 in respect of children and 2013 in respect of domestic abuse.
 - 5.3 Safeguarding Training in general has been part of the Trusts Mandatory Training programme since 2000 but this initially focussed upon children. The current training programmes are consistent with national guidance and the domestic abuse element is included in all levels of adult and children safeguarding training.
 - 5.4 St Helens Local Safeguarding Children's Board with the support of the Domestic Violence Coordinator deliver training for agencies including colleagues within the voluntary sector on the following issues;
 - Safeguarding Children Awareness,
 - MARAC and MeRIT awareness,

- Domestic abuse awareness and
- Domestic abuse and children's safeguarding,
- Forced marriage awareness, Honour based violence, and
- Female genital mutilation.
- 5.4 Healthy schools team work closely with DV Services and have put together a DV Training package for staff. They have also included two toolkits to address DV on their learning platform.

6.0 The Facts

The Facts.

Background of Victim and Perpetrator.

- 6.1 At the time of his death Ben was a 38-year-old male who had enjoyed full time employment at an engineering company prior to that company closing. This closure resulted in Ben losing his job and subsequently his home.
- 6.2 After losing his home Ben then moved into the home of his sister Frances's before later moving in with Alison at a Housing Association property she rented in St Helens.
- 6.3 Whilst in the relationship with Alison, which saw the birth of Bens first child, Ben found new employment at a local hotel where he worked for two years before his death.
- 6.4 Until the final period of his relationship with Alison the sister Ben had shared a home with Frances acted as a refuge and confidant for Ben who disclosed to her the level of domestic abuse he was suffering at the hands of Alison.
- 6.5 Unfortunately, because of a threats Frances had received from Alison, Frances was forced to move home into a neighbouring Authority area. Such was the strength of the support Ben received from his sister Frances during his relationship with Alison that Frances feels that "Ben felt I'd betrayed him when I moved."
- 6.6 Prior to the commencement of his relationship with Alison, Ben had no known history. However, during his relationship with Alison there were a total of 11 incidents, including the fatal attack, of domestic abuse reported to Merseyside

- Police involving Alison and Ben. During his relationship with Alison Ben received two Police cautions for possession of cannabis.
- 6.7 Alison is 28 years of age and has three children each from a different relationship. The children are aged 11 years, 6 years and 2 years of age.
- 6.8 Following the birth of her first child in 2003 when Alison was 17 years of age she has lived in Housing Association properties with the different partners of each of her children. Alison was unable to remain living in her parents' home following the birth of her first child as the parents were Schedule One offenders and at that time had two children on the child protection register.
- 6.9 With the support of her Social Worker Alison was able to obtain a joint tenancy of a property, with the father of her child, from a local housing association. This relationship ended after two years.
- 6.10 In 2006 Alison began a new relationship with Duncan which lasted for 18 months years and resulted in the birth of Alison's second child.
- 6.11 Alison began a relationship with Ben in 2010 and this continued until the fatal incident in 2014. This relationship also resulted in the birth of her third child.
- 6.12 Over the period subject of this review Alison has been involved in a total of 33 domestic violence incidents reported to Merseyside Police. Alison's role within the disputes has been that of victim and of perpetrator and she has one Police caution for an offence of assault committed against a former partner in August 2007. These incidents have spanned all three of her relationships
- 6.13 Stephen Mc.Gilvray visited Alison in HMP Styal following her imprisonment. Alison claimed both she and Ben constantly consumed alcohol though Alison claimed this was to help her to sleep at night.
- 6.14 Alison explained that the only action which agencies could have taken to prevent this murder from happening would have been to have been told by a Social Worker that "she must leave her partner or they would take my children"
- 6.15 However, Alison also explained that she would "say anything to the Social Workers to stop them taking my kids" and that she always was careful to "put on a show" (Making sure everything in the house was clean and tidy) "for the Social Workers to get them out of my house."

Summary of events.

- 6.16 During the period subject of this Review Alison had three significant relationships with male partners, the first commencing in 2003 which included the birth of her first child.
- 6.17 Throughout each of these relationships there is a pattern of domestic abuse incidents which together form the key events within this Review. This section of the report will summarise those key events with a complete and detailed chronology of events taking place between 2003 2014 included at Appendix B of this report.
- 6.18 Following the birth of Alison's first child in 2003 there was engagement of Health Visitors and Children's Services with Alison her partner Colin and their new born. Precipitated by the risk that Alison and her new born initially continuing to reside with her mother and step father both of whom were Schedule 1 offenders presented. With support of key workers Alison and Colin were able to obtain tenancy of a housing association property which they moved into with their child.
- 6.19 In September 2004 Alison sustained a wrist injury requiring hospital treatment which Alison disclosed to the Health Visitor at her G.P. surgery had been sustained when she punched her hand through a glass window in anger. Furthermore, Alison stated that she was frightened that she may harm her child and partner. Whilst information sharing was good between Health and Children's Services officers at this time the risks associated with this incident were not shared with agencies at any future DVIC or MARAC meeting nor was a risk assessment completed on her child or partner.
- 6.20 During 2004 2005 several incidents of domestic abuse and violence between Alison and Colin were reported to Merseyside Police. None of these resulted in the arrest of either party nor the sharing of this information with any other agency.
- 6.21 This period also documents the Alison's and her partners use of alcohol as a factor in disputes, an issue which continues throughout the period of this Review.
- 6.22 Following the ending of her relationship with Colin there was a gap of 18 months before Alison began a relationship with Donald. During this new relationship Alison became pregnant and her second child was born.
- 6.23 Domestic disputes including violence occurred early and frequently in this new relationship as did the knowledge amongst Alison and agencies that Donald was suffering from a form of mental illness. Indeed, Donald spent a considerable length of time in hospital receiving in-patient treatment for mental

illness during the period of his relationship with Alison. During this time treatment services established that;

"The primary motivating factor behind the alleged abuse was considered to be his (Donald) deteriorating mental state rather than the classic factors associated with domestic abuse, power and control etc."

- 6.24 Merseyside Police arrested Donald on three occasions between February and October 2007 for assaulting Alison. On two occasions following Donald's arrest Alison failed to support a prosecution. Police however administered a caution to Donald following the first arrest. Following the second arrest Donald was charged with assaulting Alison but the charge was later discharged at Court as Alison failed to attend to give evidence. The third arrest did result in a Court appearance for Donald who was made the subject of an 18-month Community Order which included a mental health treatment requirement and a condition of residence.
- 6.25 In April, 2007, Alison was seen by her G.P.in his surgery who discussed with her that in view of Donald's alleged mental health problems, use of cannabis, alcohol misuse and the two recent domestic violence incidents between Alison and Donald the G.P. believed that Donald was an unsuitable partner for her. Records show that Alison in response minimised the incidents of domestic violence and planned to continue her relationship with Donald.
- 6.26 In July 2008, a Social Worker from Children's Services conducted a home visit to the home of Alison. Alison was asked about the level of contact she now had with Donald and she replied, that "she would stab him if he came near her or her children." Records of the visit show that during the visit the Social Worker saw a man hiding in the bathroom of the house who they believed to be Donald. The Social Worker did not challenge the male or Alison regarding his identity. Prior to concluding the visit, the Social Worker asked Alison if there was anyone in the house that shouldn't be there and Alison assured them that there was not.
- 6.28 In 2010 Alison began a relationship with Ben and after three years of the relationship their child was born. Alison's two children from earlier relationships continued to live with their mother and Ben.
- 6,29 With the exception of the fatal attack and one seven weeks prior to that during which injuries were caused a summary of the incidents of domestic disputes occurring between Alison and Ben which Police Patrols attended would be records that one or both parties had been consuming alcohol and Police recorded the incidents as verbal disputes only with no violence.

- 6.30 Several referrals to multi agency DVIC and in one case a MARAC meeting were made as the result of disputes between Alison and Ben. With the exception of the MARAC meeting were a number of actions were agreed by agencies to prevent a renewal of the domestic abuse the outcome of the DVIC meetings was that the situation should be monitored or the fact that the case of Alison and Ben was already "open" to one of the support agencies and therefore no further action was necessary.
- 6.31 Following a dispute in August 2013 following a DVIC meeting Health Visitors completed a Pre CAF assessment. The Health Visitor felt there was no requirement for a full CAF to be completed and that the family would be adequately safeguarded within universal services.
- 6.32 In December 2013 Children Services received a referral from the school attended by the two elder children. This was in response to contact with the school made by ex-partner Colin who had advised the school that Ben had smacked his child. Colin expressed concerns that Alison was drunk and that the child had told him that they were required to stay in bed until 12 noon at weekends and did not always get fed or bathed. Police were requested to attend the home of Alison by Children Services. Police report that Alison appeared drunk but was not incapable and that Ben was sober, calm and compliant. There is no record of any further action in relation to this referral by the school taken by Police, Children's Services or the School.
- 6.33 In October 2014 Merseyside Police received an emergency telephone call from Alison stating that she had been assaulted by Ben and that during the struggle she had struck him on the head with a set of keys. Ben was reported to have left the house. A Police Patrol was deployed but prior to the officer's arrival Ben called the Police to report that he had been the victim of a domestic assault and that Alison was the perpetrator. On arrival at the home Police Officers spoke to both parties, it was noted at this time that both had been drinking. On entering the house Officers saw that two of the children were visibly upset. Alison explained what had occurred and made a statement of complaint. As a result, Ben was arrested.
- 6.34 When later interviewed at the Police Station Ben stated that earlier that evening he had acted in self-defence and had taken hold of Alison only after being stabbed by her in the head whilst he had his back facing her. Ben also informed the interviewing officer that 18 months prior to this he had been stabbed in the hand by Alison and showed the officer the scar which had resulted from that stabbing. Ben told the officer that he had not reported that stabbing at the time.

- 6.35 Police sought the advice of the CPS in relation to the incident on 17th October only. CPS decision was to refuse the charge against Ben due to insufficient evidence. No criminal action was taken against Alison in respect of injuries to Ben received on 17th October 2014 or the injury to Ben 18 months prior to that date.
- 6.36 No MeRIT risk assessment or VPRF1 were completed in respect of Ben for the incident on 17th October 2014 or the incident he told Police about occurring 18 months prior to that.
- 6.37 The dispute of 17th October 2014 was however referred to the next MARAC meeting at which a number of actions were agreed. In November 2014, the date of next MARAC meeting there was no review of the case involving Alison and Ben and actions which had not been delivered from the previously agreed MARAC safety plan.
- 6.38 Alison and Ben resumed their relationship and in December 2014 at 01.14 hours in the morning Ambulance Control informed Merseyside Police about a stabbing incident at the home of Alison and Ben. They advised that Alison had contacted their Control stating that she had stabbed Ben.
- 6.39 Police Patrols were deployed to the incident and upon their arrival found Ben lying on the floor in the doorway of a neighbour's house. Alison was crouched beside him screaming and in distress and had to be removed immediately from the scene. Whilst at the scene Alison admitted to the Police Officers that she was responsible for the stabbing and directed them to the knife she had used which remained in the kitchen of her house.
- 6.40 Ben died as a result of that fatal attack.
- 6,41 During her interviews at the Police Station Alison maintained that she had acted in self-defence as Ben had grabbed hold of her by the throat. The advice of the CPS was sought and authority was given to charge Alison with murder.
- 6.42 Following a not guilty plea to the charge of murder a trial was held in June 2015 at Liverpool Crown Court and at its conclusion the jury found Alison guilty of murder. On 6th July 2015 Alison was sentenced to life imprisonment with a tariff of 14 years.

7.0 Analysis

- 7.1 The DHR Panel agreed the following key lines of enquiry be undertaken as part of the review of this case. Analysis will now take place against each of those key lines of enquiry.
- 7.2 Key line of enquiry.

How did your agency deal with reports of and/or knowledge of incidents of domestic abuse within the family?

- Were responses appropriate and in accordance with agency policy in relation to tackling domestic abuse.
- In particular were matters relating to an alleged offender managed effectively and robustly: were responses to alleged victims sympathetic, supportive and timely?
- 7.3 Generally action taken by individual agencies was timely and in accordance with their policies. There are however a number of occasions when this was not so.
- 7.4 Firstly on 29th December 2004 a domestic dispute took place between Alison and Colin. The telephone call made by Colin to Merseyside Police reported that Alison "was being violent and was stressing out their baby." Merseyside Police policy requires that in all cases of domestic violence that they attend where a child or young person is present then the facts of the incident must be shared with Children's Services in order that appropriate safeguarding action may be taken. That referral did not take place following this incident and information regarding the incident was not therefore shared with key safeguarding agencies.
- 7.5 Secondly following the arrest of Ben after the incident at their home address on 17th October 2014, Ben was interviewed at St Helens Police Station regarding the complaint of assault made by Alison.
- 7.6 During that interview Ben disclosed to the interviewing officer that 18 months prior to this date Alison whilst under the influence of alcohol had stabbed him in the hand, showing to the officer the scar which this knife attack had left. Ben did advise the officer that he did not report this incident at the time.
- 7.7 It has since been established that Ben's disclosure of a stabbing was not recorded as a crime and no consultation with the Crown Prosecution Service over this matter took place prior to Ben's release from Police custody the charge against him having been refused.

7.8. Failure to record this crime is not consistent with National Crime Recording policy. Home Office Counting Rules, National Crime Recording Standard 1 as amended, April 2015 states that.

Para. 2.2 An incident will be recorded as a crime for victim related offences if on the balance of probabilities;

The circumstances of a victim's report amount to a crime defined by law. And

There is no credible evidence to the contrary immediately available.

7.9. The Home Office Counting Rules also provide guidance to officers on actions which should be taken when faced with an unwilling witness.

Para. 3.5. Victim focussed recording

Where apparent criminal activity comes to the attention of the Police and the victim confirms that a crime has taken place but declines to support an investigation or prosecution a crime must still be recorded.

- 7.10. The conditions of Standard 1 paragraphs 2.2 and 3.5 both appear to have been met in this case and the investigating officer should in accordance with the National Crime Recording Standard have recorded this historical stabbing as a crime.
- 7.11. This disclosure by Ben and the failure to take any further action by the investigating officer is the subject of further comment later within this report when considering the level of understanding of risks and if risk has been effectively managed.
- 7. Two further examples of when agency policy was not followed relate to firstly a Common Assessment Framework assessment that had been completed by the school attended by Alison's two older children. The school having completed the CAF then failed to progress this work. The result being that the concerns were not monitored via Child in Need procedures, no family action plan meetings were held, and there was no plan of intervention in place. The completion of a CAF would not trigger a referral or oversight by Children's Services without a direct referral from the lead agency (school) completing the CAF. The electronic system for completing CAF's which went live in 2010 would still render the CAF invisible to statutory agencies without consent. Access to the CAF would be restricted to only those agencies to whom the parent/carer has agreed to share their information, often the agency completing the assessment.

7.13 Secondly risks to the unborn third child were hidden from front line maternity staff dealing with Alison during the antenatal period of her care because of the failure to include domestic abuse warning alerts on the electronic information system used for patient notes within the Maternity Unit. The increase in levels of risk of domestic abuse faced by victims during pregnancy is well documented and this omission from the system used by staff in contact with victims therefore had the potential to cause risk to Alison, her unborn child and her two children from previous relationships.

Key line of enquiry.

Were there opportunities for agencies to identify and assess domestic abuse risk?

What was the Agency responses to any identification of domestic abuse issues?

There is evidence to indicate that the lack of a clear and coherent policy which bound together the various multi-agency meetings to which this vulnerable family were referred did lead to some safeguarding issues not being acted upon. Apart from the interventions put in place at the MARAC meeting of 6^{th} November, 2014 there is no other evidence of referrals being made to treatment or support services for the perpetrators of domestic abuse in this case by any of the multi-agency meetings held between 2003 - 2014.

- 7.14 There are a number of multi-agency meetings to which incidents involving Alison, her three children and her three partners were referred for the purposes of increasing the level of safety within this family group. These included;
 - DVIC
 - MARAC
 - MASH
 - Children's Safeguarding; Child Protection Conference Child in Need Meetings
- 7.16 Each of the above meetings consider the multi-agency response towards individuals, children and adults, who are vulnerable. However, there is currently no written policy in place nor overall management oversight of the relationship between each of these meetings and the means by which information is shared, progress monitored and outcomes evaluated between the meetings.
- 7.17 In the absence of a current and robust information recording and sharing system open to representatives of agencies attending these meetings and without robust management oversight and challenge it is possible for individuals and the risks they face to be overlooked

7.18 Children's Services observe within their IMR that

"The children became lost within the processes that exist to manage the risks created by domestic violence and that the voice of the children had not been captured effectively throughout a number of different multi-agency processes. Had the social work assessments been more child centred more information would have been gathered, particularly in relation to the dynamics of the family."

- 7.19 There are a number of other examples of safeguarding issues not being identified and acted upon.
- 7.20 The clear identification of risk followed by inaction is shown within Children's Case Records and MARAC meeting minutes in 2007 which show;
- 7.21 Children's Case Records of 15th October 2007 state that Alison is in a relationship with Donald "who when (Donald's) mental health is poor is a risk to the children"
- 7.21 The MARAC of 21st October 2007 minutes record that; "Donald is schizophrenic and is known to be not taking his medication. Children Services state Donald is a risk to the children." This information was shared with Health Visitors linked to the family.
- 7.22 Apart from sharing the information with Health Visitors the first time agencies outside of Children's Services became aware of this information was the MARAC meeting of 21st October 2007 were the risk posed to the children of Alison by Donald was shared with all who attended the MARAC.
- 7.23 However, there were no safety plans recorded at the MARAC meeting which may have reduced the level of risk faced by the children caused by Donald's poor mental health. Nor a referral of Donald by a multi-agency domestic abuse meeting to mental health treatment services. The severity of Donald's mental illness at the time this lack of action was taking place is revealed below.
- 7.24 At various times during 2007 Donald spent time in hospital and it was assessed that the primary motivating factor behind his abusive behaviour was Donald's deteriorating mental health. He was assessed as clearly experiencing psychosis and was unstable.

- 7.25 During this period, there was also frequent contact, in large part initiated by Alison, between Alison and Donald which continued despite the bail conditions imposed on Donald by the Courts, and the advice and exclusion from the ward by hospital staff of Alison.
- 7.26 Alison was shown to disregard hospital advice regarding contact with Donald thus placing herself at risk and furthermore in August 2007 Donald disclosed to the AOT that Alison had become pregnant by him.
- 7.27 Throughout this time AOT records show that;
 "Due to the unstable nature of Donald's illness there were numerous contacts with the Police regarding the safety of Donald and his bail conditions."
- 7.28 However in spite of the following risks there is no record of a MeRIT. domestic abuse risk assessment being completed by any agency in respect of Alison her existing children and unborn child at the point of Donald's discharge from hospital in January 2008. The following risks therefore took place without any multi agency information sharing or action in order to reduce risk.
 - The risk that Donald's mental health posed to others
 - The disregard Alison had shown to advice from hospital staff regarding her safety which Mental Health Services record as being "higher due to Alison continual attempts to have contact with Donald particularly when both abused substances and or alcohol."
 - A further domestic violence incident resulting in a MARAC review
- 7.29 On 9th November 2007 a Child Protection Conference was held and at its conclusion Alison's eldest child was placed on the Child Protection Register because of the emotional abuse she suffered as a result of the ongoing domestic abuse incidents occurring within her home.
- 7.30 Over the next 6 months there are no reported incidents of domestic abuse taking place in the home between Alison and Donald. This fact may lend some credence to the statement by Alison who when visited in prison stated that the only action which agencies could have taken to prevent this murder from happening would have been to have been told by a Social Worker that "she must leave her partner or they would take my children"
- 7.31 On 21st April, 2008, Alison's eldest child was removed from the Child Protection Register but continued to be reviewed as a Child in Need, level 3b. The youngest child remained on the Child Protection Register until May 2008 when she was stepped down to a Level 3 Child In Need.

7.32 This level is defined as follows;

Level Three: Children in Need

Children with complex needs that may be chronic and enduring and whose health (physical & emotional) and development may be significantly impaired without the provision of services. This may include some children who are in need of safeguarding. Children with a disability are also children in need.

- 7.33 Within one month of a multi-agency decision to step down the cases of Alison's two children from a Child Protection Plan (level 4) to a multi-agency Child In Need plan (level 3). Alison was once again coming to the attention of agencies for her involvement with Donald.
- 7.34 On 13th May 2008, case notes from the AOT show that Donald had been observed close to his home walking with Alison who was pushing a pram. This information was passed from the AOT to Children's Services. The youngest child remained a Level 3 Child In Need at this time.
- 7.35 On 17th June, 2008 Alison in "a drunken state" attended the home of Donald and an argument then ensued between the two regarding access to their child. Police responded to a call at the address but there were no arrests and the matter was referred to DVIC.
- 7.36 One month later on 19th July 2008 during a home visit by a Children's Services officer the officer asked Alison about her level of contact with Donald. Alison stated "*If he comes near me or my children I will stab him.*" A male believed to be Donald was seen to be present in the toilet whilst the officer conducted the visit. Neither the male suspected of being Donald nor Alison were challenged over this male's presence or identity.
- 7.37 NSPCC review of lessons learnt from case reviews published in 2013, states that:

Information about who lives in the home and who has contact with the children should be verified and kept up to date. The identity of any unknown males in the house should be investigated.

NSPCC Domestic abuse; Learning from case reviews November 2013

7.38 The incidents of May, June and July 2008 indicate that Alison was maintaining contact, with and even allowing into her home, Donald who had previously been identified as a risk to the safety of the children of Alison.

- 7.39 There are no records within those which have been made available to this Panel to indicate that any MeRIT risk assessment checklist or other Safeguarding action was discussed or taken either by an individual agency or by multi agency DVIC or MARAC during meetings in regard to this apparent risk to the children, emerging from the renewed contact between Alison and Donald.
- 7.40 Additionally there are no records to show that the discussion and outcomes of the DVIC meetings in relation to these incidents were acknowledged or considered by the Child In Need meetings.
- 7.41 One month later in August 2008 the Children In Need cases of Alison's children were closed to Children's Services.
- 7.42 The final example of a safeguarding issue not being acted upon relates to a Common Assessment Framework (CAF) assessment which had been completed on the children and family of Alison and Ben by the school which the two elder children attended and other information provided by the school subsequent to the death of Ben.
- 7.43 Neither DVIC nor MARAC currently have a representative from school's present at their meetings. Representatives from Behaviour Intervention Team and Education Welfare Officers have represented the schools in the past but this representation and presence has now lapsed, and the schools absence may have restricted the effectiveness of those and other safeguarding meetings in this case through the lack of important information being shared by the school.
- 7.44 A 2010 Report by the NSPCC, "Children and Families experiencing domestic violence: Police and Children's Social Services Responses", indicates that 29% of the cases analysed involved children of school age, aged 5 10 years, (ages at the time of the two elder children) within the family group
- 7.45 Social work assessments that have taken place following the domestic homicide reflect that the children's school were very concerned about the care of the two older children.
- 7.46 The school had frequent concerns about Alison turning up at school either smelling or under the influence of alcohol.
- 7.47 A common assessment framework had been completed by the school on the family but this was not followed up by the school and monitored via Child In Need procedures, neither had any family action meetings been convened,

thus there was no plan of intervention in place to safeguard these children following the schools initial expressions of concern.

- 7.48 The school later advised that they had been reluctant to raise issues with Alison for fear as to how she may react. The school have since reported that the younger child's behaviour in school would escalate on a Friday afternoon and would show increased anxiety as the weekend approached. (This is consistent with the view from the family of Ben who state that the level of domestic abuse was far greater than that reported to Merseyside Police as every weekend Alison would drink heavily and a domestic dispute would take place resulting in Ben seeking sanctuary with friends and family.)
- 7.49 Children's Services in their IMR state,
 "Why this information from the school was not shared earlier and reflected in
 the social work assessment undertaken in November 2014 is unknown."

Key line of enquiry

Was communication and information sharing between agencies timely and effective?

- Did it lead to a clear understanding of the complexity of the issues within the family and was the approach to helping the family properly coordinated?
- Were plans formulated holistic with a long term problem solving approach rather than being incident driven?
- How effective was joint action managed and delivered through the MARAC process. Were resources/capacity an issue in relation to service delivery?
- 7.50 There is evidence of some good information sharing during the period reviewed by this Panel.
- 7.51 In 2004 following the birth of Alison's first child there is evidence of good communication and joint working between Health Visitors, Children's Social Workers, and Housing Providers which identified a risk in relation to Alison's parents. New accommodation was quickly found for Alison and her new born child thus removing the child from risk.
- 7.52 In December 2012 Police Officers are shown to share information with the Maternity Unit, Health Visitors and Children's Services following a domestic dispute between Alison and Ben prior to which Alison who was pregnant at the time had been consuming alcohol. This case was not discussed at DVIC and therefore the risk to the unborn child would not otherwise have been shared.

- 7.53 However, in terms of agencies working with this family and engaging in a multi-agency approach to reduce risk the answer to this question is best exemplified by the contrasting views of two key agencies coming into contact with and supporting this family.
- 7.54 Merseyside Police in their IMR conclude that "This murder could have been predicted but was not preventable."
- 7.55 Children Services in their IMR reflect that,
 "There had been little previous indication that the level of previous domestic violence was indicative of a potential homicide."
- 7.56 No evidence has been made available to this Panel to show that a number of key pieces of information which would have assisted in accurately determining the level of risk were shared between relevant agencies or at meetings the purpose of which was to reduce levels of risk and increase levels of safety.
 - 7.57 On 23rd September 2004 a Health Visitor working in the G.P. practice of Alison telephoned Children's Services advising that three days earlier Alison had punched her hand through a window at her home in anger and that Alison had now disclosed that she "was frightened she may harm Colin and may harm her child"
 - 7.58 Three weeks later the Health Visitor and Children's Services conducted a joint visit to the home of Alison. It was established during this visit that Alison had refused to attend an anger management course which had been arranged for her by the G.P. following this disclosure.
 - 7.59 No further action was taken and there is no record of Alison disclosure or refusal to attend anger management training being shared with any other agency nor of any risk assessment in respect of Colin and her child being completed.
 - 7.60 On the 20th August 2007 Alison received a Police administered caution following an assault she made on Colin. There is no recorded evidence to show that this information was shared with agencies at any future DVIC or MARAC meeting.
 - 7.61 Merseyside Police in their IMR note;

That domestic incidents which involve excessive alcohol use (the presence of this risk will be dealt with later within this report) and the allegation of possession or use of a knife should be very carefully risk assessed even if no injuries have occurred. The assessment should take account of the fact that

in any future domestic conflict this combination of risk factors will significantly increase the possibility of serious injury or death. This risk relates not only to the parties concerned but to any front line agency worker who may come into contact with them.

- 7.62 Despite the Police statement regarding knives on 19th July 2008 a Social Worker completed a planned visit to the home of Alison after a domestic violence incident involving Donald. The Social Worker enquired of Alison about the level of contact she currently had with Donald. Alison replied "If he comes near me or my children I will stab him." There are no records to indicate that this information was shared with any other agency or referred to at any future multi-agency meetings relating to Alison and there is no evidence of a risk assessment being undertaken in respect of Donald by the Social Worker.
- 7.63 Maternity records relating to the birth of Alison's third child in 2013 illustrate a further example of poor communication between agencies. Throughout the antenatal period there was no knowledge within Maternity Services of Children's Services involvement with the children of Alison until close to discharge of Alison and her new born.
- 7.64 The NHS Trust were however aware of issues of domestic abuse because of information shared with them by the Police and throughout the domestic abuse multi-agency meetings. The result was that when the youngest child was discharged from hospital a discharge meeting was convened at which actions were agreed and followed up. The post-natal care of Alison involved a maternity "cause of concern" process which was followed up with appropriate links being made with Community Staff upon discharge.
- 7.65 Ben following his arrest on 17th October 2014 disclosed that during the course of a domestic dispute 18 months ago, prior to which Alison "had been drinking and had become obnoxious and violent which she always did after consuming alcohol", he had been stabbed in the hand by Alison.
- 7.66 Ben had not reported this stabbing at the time but having made this disclosure the information was not shared by the investigating Police Officer with the FCIU or any other agency and could not therefore form part of the decisions regarding risk or safety/action planning.
- One must speculate that this murder could have been prevented if these two disclosures by Alison and Ben both relating to stabbing had been firstly shared with other MARAC agencies and secondly, "very carefully risk assessed".

- 7.68 These examples represent long term and systemic failures to share important information between agencies which led to flawed decision making and placed at further risk the safety of Alison her partners and her children.
- One must therefore also conclude that weaknesses in information sharing inhibited this partnerships understanding of the complexities and risks present in this case. It was also responsible for creating the significant gap in the perception of overall risk possessed by these two key agencies.
- 7.70 The weakness in information sharing was compounded by the management of MARAC's and DVIC's held in respect of Alison her partners and their children none of which appear to have taken a long term problem solving approach to resolving these domestic tensions.
- 7.71 The MARAC and DVIC both suffered from;
 - Limited information sharing
 - No reference to previous incidents or partnership meetings held to reduce risk following these incidents
 - Poor action plans with
 - No follow up of safety/action plan outcomes
 - No reassessment of risk.
 - No strategy to overcome barriers presented by a lack of engagement from victim or perpetrator.
 - An absence of proactive prevention strategies relating to parenting alcohol and substance misuse
- 7.72 It is acknowledged by agencies in their IMR's that incidents of domestic violence in this case were responded to as an individual set of incidents with no reflection or analysis of the cumulative impact of the series of incidents
- 7.73 The Community Healthcare Trust note that information shared with Health Visitors following a DVIC meeting at which the Health Visitor was nominated as the lead professional following an incident of domestic abuse was presented in such a way as to indicate;

"The incidents were assessed in isolation of previous incidents pertaining to those adults and children."

Repeat referrals of cases involving these adults and children did not in the opinion of the Trust result in an escalation for assessment by Children's Services or a multi-agency case review.

7.74 Children Services IMR notes:

"During the early life of the case between 2004 and 2008 incidents of domestic violence were responded to as an individual set of incidents with no reflection or analysis of the cumulative impact of the series of incidents. As a result of this opportunities were missed to address at an earlier stage the true scale and impact of domestic violence these children were exposed to."

- 7.75 As a result of these weaknesses, opportunities were missed to address at an earlier stage the true scale and impact of domestic violence everyone who was part of Alison's family, her children and her partners and all front line delivery staff who had contact with them were exposed to.
 - 7.76 However, paragraph 6.2 of the DVIC Protocol, developed and agreed by this Partnership, states that the meeting;

Will decide which agency should undertake the key role in each case. That agency will allocate a key worker who will be responsible for ensuring that the appropriate support or service is provided and that clear outcomes and expectations of the worker will be outlined at the DVIC meeting. Feedback on progress will be required by the key worker and will be recorded at the DVIC meeting within four weeks from the date of allocation."

- 7.77 Cases in which Alison was either a victim or perpetrator of domestic abuse were referred to the DVIC on 11 occasions between 2003 2014.
- 7.78 In respect of any outcome or safety plan emerging from these 11 DVIC meetings, minutes show that;
 - On two occasions no outcome or safety plan was recorded at the conclusion of the meeting.
 - On four occasions the outcome or safety/action plan was simply that the
 case was open to South East Child and Family Team (SE C & F) and that
 having been said no action was then allocated to the SE C & F team to
 deliver.
 - Two DVIC meetings concluded that the case was allocated or open to Health and again no action was then allocated to Health to deliver.
 - On three occasions, the outcome recorded was for agencies to monitor.
- 7.78 Records also show that on only one occasion did DVIC review these cases outcomes, or action plans at a subsequent meeting.
- 7.79 This myopic approach also inhibited the development of evidence based action plans at MARAC as key information detailing the work of the DVIC meetings was not brought to MARAC meetings.

- 7.80 Following the incident on 17th October 2014 the relationship between Alison and Ben was scheduled to be discussed at the MARAC meeting on 6th November 2014.
- 7.81 The following information was not found to have been shared with the agencies attending the 6th November 2014 MARAC meeting;
 - Information regarding outcomes of previous DVIC meetings
 - Records of the previous IDVA Service provider which were not provided to St Helens Community Safety Partnership who commissioned the service when that contract was ended and who may have held information relating to Alison's relationships with Colin and Donald. (Access to these records has since been obtained by this Review and illustrate limited contact between the IDVA and Alison in 2008 and that offers of support/help in relation to a Court hearing from the IDVA was declined by Alison.)
 - There is no evidence of the MARAC meeting being made aware of the two arrests of Alison following domestic abuse incidents. Once for causing a Breach of the Peace and once for committing a Section 39 Common Assault upon a previous partner.
 - Records of the frequently intoxicated state of Alison at the scenes of domestic disputes.
- 7.82 Children's Services comment in their IMR that their information
- "suggests that social care and MARAC risk assessment processes focussed too much on Alison being the victim of the violence and failed to sufficiently acknowledge her role as a perpetrator. Alison's two previous partners and fathers of two of her children had previously made allegations of assault against Alison, but this information was not contained within social work assessments."
- 7.83 Maternity Services also acknowledge that during the antenatal care attention was naturally upon Alison with no attention given to Ben. The Trust note that;
 - This was perhaps an opportunity to better understand the dynamics of the relationship and the potential for Alison to be a perpetrator rather than a victim. A greater awareness of the complex dynamics within abusive relationships needs to be further iterated."
- 7.84 In October 2014 in accordance with the St Helens MARAC protocol, having been advised that the incident of 14th October 2014 would be discussed at the MARAC meeting 6th November 2014, agencies began to take action.
 - By 21st October 2014 Children's Services had completed their assessment and referred Ben to Addaction and Help and Alison to the Freedom program (domestic abuse support program). They concluded that they

- would be taking no further action and the case was closed by them on 24th October 2014.
- By 28th October 2014 the IDVA Service had made contact with Alison who advised that she had resumed her relationship with Ben and that she did not require IDVA support. The case was then closed by the IDVA Service.
- 7.85 The safety plan agreed at the MARAC meeting of 6th November then included the following action points;
 - Alert the Police Neighbourhood Team
 - Health Service to continue to support
 - Community Health Trust on going
 - · Helena Partnership, (Manager of the IDVA Service) to continue support
 - Ben referred to Addaction
 - IDVA to offer support once more to Alison
- 7.86 Safe Lives (Formerly CAADA) acknowledge that with the introduction of DHR's, action/safety plans developed at MARAC need to be consistent and auditable.
- 7.87 This Partnerships MARAC Procedure and Protocol manual states in Paragraph 21.2:
 - Action Plans should be SMART and should be explicitly documented in the minutes by the Domestic Violence Administrator.
- 7.88 However, none of the actions from the MARAC meeting of 6th November 2014 are SMART and are so general in nature that they are difficult to audit.
- 7.89 The actions sought continued support from the IDVA Service who had already closed their file on this case and include details of an action already undertaken by Children's Services, but with no requirement to monitor if the referral was taken up by Ben at Addaction or Alison at the Freedom program.
 - 7.90 In the action plan of 6th November 2014 MARAC does not appear to take cognisance of the history of this relationship or support for Alison regarding alcohol treatment, nor is there reference to any risks faced by the children living within this relationship or of any plans to reduce that level of risk. This short term single incident approach, and weaknesses in the management of the MARAC and DVIC meetings appear to have rendered the multi-agency approach less than effective in this case.

Key line of enquiry

Did professionals display appropriate understanding of the risks presented within this family.

- Were the risks effectively managed and was supervision and management adequate in providing control and direction.
- 7.91 Safe Lives include within an Aide Memoire for Chairs of MARAC meetings a reminder to:
 - Specify actions which are outstanding from the last MARAC, include details of the agency/organisation responsible, the case number and the reason why that action is incomplete".
- 7.92 Upon commencement of the DHR process it was identified that elements of the MARAC action plan in respect of Alison and Ben and their children agreed on 6th November 2014 was not reviewed at the next MARAC meeting held on 20th November 2014.
- 7.93 Immediate steps were taken by the Community Safety Partnership to ensure this was not repeated and now all actions from the previous MARAC meeting are the first item on the agenda of every MARAC.
 - "MARAC's need to be measured by their risk management actions and the outcomes of their multi-agency activities. We found examples of MARAC's that did not monitor risks or did not properly track the actions that it had agreed."
 - HMIC 2014 Everyone's Business; Improving the Police response to domestic abuse.
- 7.94 Currently if a victim or perpetrator fails to engage with the MARAC safety/action plan, unless new information is forthcoming no further action will be taken by this MARAC. (Alison has a history of failing to engage and more detail will be found later within this report.)
- 7.95 Whilst the Domestic Abuse Co-ordinator explains that this is because there is not the capacity to perform this extra level of safety planning this Review was unable to find evidence that such reassessment of risk has ever been practice of the DVIC or MARAC meetings held by this Partnership.
- 7.96 This is in spite of such omissions being contrary to the agreed Partnership MARAC Procedure and Protocol and this will be subject of further comment later within this report. In this case there was no MARAC review of their original MeRIT risk assessment or action plan in light of this lack of engagement. Therefore the risk remained at least at the same level as pre MARAC.

- 7.97 This failure to reassess risk on the basis of evaluating engagement of the key individuals in the action plan is also present at a single agency level. Children's Services acknowledge that Alison and Ben lack of engagement with Addaction, the Help program and the Freedom program was not followed up by their staff prior to closure of the case.
- 7.98 The effectiveness with which levels of risk were managed was also challenged by the actions of the Police investigating officer. Following the arrest of Ben after the incident at their home address on 17th October 2014, Ben was interviewed at St Helens Police Station regarding the complaint of assault made by Alison.
- 7.99. During that interview Ben disclosed to the interviewing officer that 18 months prior to this date Alison whilst under the influence of alcohol had stabbed him in the hand, showing to the officer the scar which this knife attack had left.
- 7.100 Regarding this historical stabbing information the interviewing Police Officer took no further action and, failed to complete in accordance with Force policy, a MeRIT Risk Assessment form or submit a VPRF1 in respect of Ben to the FCIU.
- 7.101 Safe Lives recommend the "most common way of managing counter allegations in domestic incidents is to share the information to help agencies in particular the IDVA service."
- 7.102 Failure to complete a MeRIT risk assessment and a VPRF1 prevented the information from being shared at the MARAC of 6th November 2014.
- 7.103 In respect of this omission the Police IMR states that the interviewing officer when interviewed stated that he,
- "Was not aware that course of action, (Recording the crime and completion of VPRF1) should have been undertaken as if that was the procedure then there would be a requirement to do this for every person making a counter allegation or historical unreported allegation when arrested for a domestic incident."
- 7.104 Aside from the failure to follow Home Office Counting Rules policy discussed earlier these actions show a lack of understanding of risk in domestic abuse cases especially when viewed against the history of Alison and Ben relationship which was available to the officer during the time that Ben remained in Police custody.

- Alison had previously been discussed at 11 DVIC meetings and 1 MARAC meeting.
- Alison had previously received an Adult caution for an offence of violence committed against a previous partner.
- Though not included as a warning sign on the Police PROtect system there is evidence contained in a large number of Police incident logs regarding Alison that on many of the occasions of domestic disputes Alison had been consuming alcohol.
- The incident of 17th October 2014, which was being investigated at this time, differs from the historical crime disclosed by Ben only in terms of the weapon used to inflict the stabbing. On 17th October, 2014, it was a key, 18 months previous it was a knife. On both occasions Alison had been consuming alcohol.
- 7.105 In spite of Ben convincing the investigating officer that he was going to end the relationship with Alison and leave, there was a strong probability that Alison and Ben would resume their relationship and live together once more.
 - Alison and Ben had during the course of their 4-year relationship reported 10 domestic violence incidents to Merseyside Police. All of these incidents had taken place at the home Ben shared with Alison which Ben moved into soon after their relationship began. Police logs show both parties living at the same address.
 - On 14th August 2014, Helena Housing record that they were assisting Alison with a Housing Benefit claim in respect of both Alison and Ben who were sharing the house.
- 7.106 This proved to be the case as by 21st October 2014 just 4 days after Ben's arrest an officer from the MASH had spoken to Alison who confirmed that the couple were back living together.
- 7.107 The incident which lead to the murder of Ben on 17th December 2014, contained the same "ingredients" as the historical incident and the incident investigated on 17th October 2014. Alison having consumed alcohol then committing a stabbing. Additionally, on 17th October 2014 and on the night of the fatal stabbing Ben had his back to Alison at the time of the attack.
- 7.108 This does indicate there has been a poor understanding of risk in domestic abuse cases shown by a number of agencies and a less than effective management of risk by DVIC, MARAC and individual agency supervision.

Key line of enquiry

How did your agency recognise and deal with root causes which contributed to the manifestation of domestic abuse within the relationship? (For example alcohol/drug abuse)

- Was action/support effective?
- If barriers prevented engagement in support what strategies were in place to overcome such barriers?
- 7.109"Full and accurate information about domestic abuse history is critical to any effective screening and risk assessment process. Reliance on records of convictions will seriously underestimate judgements about the extent and likelihood of domestic perpetration given the level of attrition in domestic violence cases."

Richards L 2004 Getting away with it; a strategic overview of domestic violence sexual assault and serious incident analysis.

7.110 The MARAC Procedures and Protocol document states that:

Para 21.5: All of the information provided by the risk indication and risk assessment elements process will have identified the issues and risk factors and indicators which underlie each case. These specific areas of concern now need to be managed in order to reduce risk

- 7.111 Over the course of three relationships from 2003 until the fatal stabbing of Ben in 2014 Alison was involved in a total of 33 domestic violence incidents reported to Merseyside Police.
- 7.112 Over the course of those 11 years on two occasions the incidents lead to a MARAC referral, and in the majority of others the case was discussed at a DVIC meeting. Throughout the 33 cases there are 13 separate references to one or both parties having consumed alcohol.
- 7.113 Police records show Alison to be the perpetrator of a domestic abuse incident on five occasions between 2003 2014 and that Alison was arrested twice following domestic incidents. On four of those occasions the Police log recorded that Alison had been consuming alcohol.

"The alcohol use of one or both partners impacts on the boundaries between victim and perpetrator with subsequent difficulties in assessing risk and in determination of who is the primary aggressor".

Hester M, Williamson E and Gangoli G Exploring the service and support of male, lesbian, gay bi-sexual and transgender and black and other minority ethnic victims of domestic violence. Rapid Evidence Assessment. Home Office

7.114 The NSPCC commissioned report November 2013 also highlighted the impact of alcohol fuelled violence within the context of a domestic setting by stating that this should "be viewed as an increased risk"

NSPCC Domestic Abuse; Learning from case reviews. November 2013

- 7.115 Out of the 13 DVIC and MARAC meetings only at the MARAC held on 6th November 2014 is there any record of a referral of one of the parties to a domestic dispute involving Alison to alcohol and substance misuse services contained within the meetings safety/action plan.
- 7.116 Children's Services IMR acknowledges that alcohol misuse was not given full consideration during the course of Social Work Assessments including the assessment of 14th November 2014.
- 7.117 The Police domestic violence incident recording system PROtect contains warning signs regarding Ben for alcohol misuse but the only warning signs in respect of Alison was one of violence there were no warning signs regarding Alison's misuse of alcohol.
- 7.118 The failure to highlight as a warning sign on the Police PROtect system habitual alcohol misuse is recognised within the Police IMR as one of the lessons to be learnt from this Review and is reflected in the action plan which accompanies this report.
- 7.119 Public Health Services, commissioners of alcohol and substance misuse treatment services in St Helens, within their IMR highlight the number of opportunities which were not taken;
 - To refer into treatment services Alison and her partners during the period subject of review.
 - To provide support to the children within the family as a result of alcohol abuse
- 7.120 Whilst details of the training programmes were included earlier within this report there is an absence within that training schedule of courses which explore the links and effects of alcohol and substance misuse within a domestic abuse relationship and the impact upon the children within that relationship. This view is reflected in the action plan which accompanies this report and the actions of a number of the Panel agencies.
- 7.121 As with alcohol misuse in this case in spite of there being evidence of need regarding mental health treatment/support available to multi-agency meetings in which Alison and her partners were the subject of discussion there are no records of any referral from MARAC or DVIC to Mental Health support or treatment services during the period 2003 2014.
- 7.122 In October 2007 there are two occasions when Social Workers from Children's Services record that Donald because of the state of his mental health is a danger to the children of Alison. There was a DVIC and a MARAC multi-

agency meeting held to discuss the two incidents at which staff from Children's Services would have been present but where there is no record that the mental health threat was shared by either Social Worker or Police Officers whose logs of the incidents also contained the issue of mental health and the risk it posed to the children within that family.

- 7.123 One must wait until an appearance at St Helens Magistrates Court in June 2008 for the Section 39 Offences Against the Person Act assault on Alison which took place in October 2007, before Donald is referred following a domestic violence incident to mental health treatment services.
- 7.124 On 24th June 2008 Donald was sentenced by St Helens Magistrates Court to an 18 month Community Order with conditions of 18 months' Probation Service supervision, a mental health treatment requirement and a residency requirement.
- 7.125 The Probation Service had only two meetings with Donald following this sentence as on 7th July 2007, Donald was admitted to Whiston Hospital having been sectioned under the Mental Health Act.
- 7.126 Donald remained in Hospital for four weeks but was readmitted under a Mental Health Act Section one month later and apart from a period of two weeks when he was discharged briefly in March 2008 he remained as an inpatient until the end of 2009.
- 7.127 A Panel agency has indicated that during this period the Mental Health Trust did not offer services from DVIC to perpetrators of domestic abuse in explanation for a lack of referral of Donald from DVIC or MARAC during 2007. However, when one examines the membership of both DVIC and MARAC meetings knowledge and access to services was sufficient within the group to have established that Donald was already in receipt of treatment and information surrounding the domestic abuse incidents may have assisted those treatment providers and facilitated additional support for alcohol misuse or mental health within safety plans. These omissions indicate poor analysis of the information prior to the meeting and poor management of the DVIC and MARAC meetings at an operational and strategic level.
- 7.128 Records available to this Panel also illustrate that on eight occasions during the period 2003 2014 Alison was offered help and support to overcome issues connected to domestic abuse. On each occasion, she either rejected that support or minimised the incident to the officer expressing concern and making the offer of support to her.

The table below details each of those incidents.

7.129 Paragraph 22.4 of the MARAC Procedure and Protocol states that;

Where actions associated with a risk plan have not been completed or there has been a failure to engage the residual risk will be considered by the Domestic Violence Coordinator and if necessary emergency measures will be considered, however in all such circumstances an update will be provided at the next MARAC.

- 7.130 The Panel were unable to find any evidence that Alison refusal to accept any offer of support or to engage with agencies following either of the MARACs but more importantly the MARAC of 6th November 2014, resulted in any further action being taken or the MeRIT risk assessment being reviewed in light of this rejection of help and support.
- 7.131 The MARAC minutes of 6th November 2014 show that:
 - Children's Services state the case was closed to them in light of the fact that the risk posed by domestic abuse did not meet the threshold required by child protection procedures, and the family do not wish for any support.
 - The case was also closed to the IDVA Service again because Alison declined the service and was resuming her relationship with Ben.
- 7.132 The MARAC minutes then show that a question was asked of the meeting,

"Are all agencies in agreement with the discussion that has taken place within MARAC and that all concerns have been raised and addressed? Yes."

No further entries are made in respect of the case involving Alison and Ben

7.133 The author has interpreted the phrase "failure to engage" contained within paragraph 22.4 as going beyond a telephone conversation between Alison and agencies during which offers of support are rejected and is requiring of a participation in activities contained within the safety plan. On that basis the

- MARAC minutes clearly illustrate that paragraph 22.4 of the MARAC Procedure and Protocol was not followed.
- 7.134 Neither can the Panel find evidence of the MARAC meeting considering the issue of an "Osman" warning. An "Osman" warning referred to in paragraph 22.7 of the MARAC Procedures and Protocol relates to, European Court of Human Rights case Osman versus United Kingdom 1998 following which case guidelines where developed.
- 7.135 These guidelines "Allow the Police in cases were all options for coordinating MARAC risk management plan have been exhausted to notify individuals in writing of dangers they feel are clearly indicated by current circumstances if they do not take advice and support offered."
- 7.136 Agencies failure to engage Alison and a subsequent failure to take any further action as a result of Alison and Bens failure to engage or to have considered the history of this case/relationship and learn lessons from what has taken place in the past illustrate an absence of strategies and processes within the domestic abuse and safeguarding partnerships to overcome barriers to dealing with the root causes of domestic abuse in this case and to deliver effective safety planning. Thus increasing the level of risk and dangers faced by Alison her children, her partners and front line agency staff dealing with this family.

Key line of enquiry

- What knowledge did family/friends have of issues within the relationship regarding domestic abuse?
 - o Were they engaged in support strategies and/or did they feel able to be involved?
 - o How will family/friends be encouraged to contribute to the review?
- 7.137 For some time Bens sister Frances lived close to the home Ben shared with Alison and the children.
- 7.138 Frances was a confidant and source of refuge for Ben who would advise Frances of all the incidents of violence which Alison had committed against him. Frances stated that disputes and violence occurred every week end as a result of Alison consuming large quantities of alcohol.
- 7.139 Alison was aware of the role that Frances played in being a refuge and confidant for Ben. Frances believes that it was for this reason that Alison had

placed a tracking application onto the mobile phone of Ben. Ben advised Frances that he was frequently challenged by Alison as to why he had visited Frances.

- 7.140 When Stephen Mc.Gilvray asked Frances why she had not reported this abuse and violence on behalf of Ben she gave a number of reasons.
- 7.141 Alison would throw Ben out of the house and since losing employment he had nowhere to live. Ben had nothing and that is why he often slept in his car. (When domestic disputes were taking place with Alison)
- 7.142 Ben believed that he had to "watch out" for the children because he drew the violence of Alison away from them and without his presence they would become the recipients.
- 7.143 It was for those reasons Ben asked Frances not to report this violence and abuse to the Police. Frances told Stephen Mc.Gilvray that having been asked not to report it she did not want to "Do anything behind his back, to be a grass."
- 7.144 Neither Erica nor Frances prior to this murder knew where they could report domestic abuse of this nature outside of the Police.

Key line of enquiry

Any other issues around equality and diversity to be considered within the review?

7.145 There were no other issues of equality or diversity raised during the course of this Review.

8.0 Conclusion and Recommendations

- 8.1 The decision by this panel to review the period 2003 2014 was made on the basis of Alison record of involvement as victim and perpetrator of domestic abuse throughout this period.
- 8.2 That decision was beneficial to the purposes of this review because it enabled the panel to establish that weaknesses in structures and processes were

endemic and not confined to the 2010 – 2014 period of the relationship between Alison and Ben.

- 8.3 Following a review of information provided to this review one must conclude that this murder may have been prevented and safeguarding levels have been higher but for the poor management of MARAC and DVIC processes and the meetings and consistently poor levels of information sharing around issues of risk and root causes of conflict within this relationship.
- 8.4 A number of IMR's contain actions concerning agency specific learning points and they are all included within this section of the report and within the overall action plan which is included at Appendix A.
- 8.5 In addition there are actions which this panel believe are relevant to address the weaknesses identified within the Partnership structures in place to deal with matters of domestic abuse and Safeguarding.
- 8.6 The development of the DVIC meeting by taking the MARAC approach and applying it to cases which are not high risk or where safeguarding thresholds have not been reached but where children have experienced the abuse taking place is a positive addition to safeguarding activities for the children and young people of to-day and the adults of tomorrow.
- 8.7 However systemic weaknesses within DVIC, MARAC and Children Safeguarding meetings including MASH thwart this positive approach.
- 8.8 It is therefore recommended that a post with clear management oversight and responsibility delivering structured supervision of DVIC, MARAC and Children Safeguarding meetings including MASH is established. This is to ensure that there is effective coordination between the meetings and a thorough and accurate awareness amongst participants of the actions and outcomes delivered by others working with these vulnerable families.
 - Delivery of this action would benefit from joint training exercises between participants at each of these meetings.
- 8.9 There is a lack of effective information gathering and preparation before meetings and a failure to place single domestic violence incidents within a wider context of the relationship. Neither is there evidence that this narrow and surface only approach to information gathering and analysis is challenged within the meetings. This issue can be traced back several years within the partnership and one might say are part of its culture.

- 8.10 Accompanying this is the absence of a strategy to overcome barriers created by the non-engagement of both victims and perpetrators with safety plans developed by DVIC, or MARAC meetings.
- 8.11 Whilst this issue will benefit from the first recommendation of this panel it will in the short term require intrusive supervision of such meetings. In order to make the change sustainable a retraining program for all Chairs of the meetings and their participants to ensure processes are delivering as complete and accurate assessment of safety needs as possible and a strategy to overcome the barrier of non-engagement must be developed and utilised. This is the second recommendation of this Panel.
- 8.12 Linked to this is the absence of a problem-solving approach which seeks to structure participation at meetings around the elements of that complex relationship. Illustrative of this is the lack of a school representatives at DVIC and MARAC meetings, and a failure to tackle the root causes of disputes and violence within the relationships. Few good examples of this approach could be found within the evidence available to the Panel.
- 8.13 It is therefore recommended that a revision of membership to MARAC and DVIC is undertaken with necessary changes made following that review and that Chairs and those supporting the Chair at these meetings apply a strong problem-solving approach to the work of the meeting with the aim of preventing repeat victimisation by addressing root causes of conflict within the relationship.
- 8.14 There are several examples found within this Review where a failure to follow policy has occurred and this has inhibited the effectiveness of the partnership response to domestic abuse.
 - MARAC meetings fail to deliver SMART objectives in accordance with the published Procedures and Protocols for this MARAC and this has made the evaluation of outcomes from meetings difficult to assess.
 - The failure to review necessary actions and safety plans at the next MARAC meeting and to reassess the level of risk when individuals fail to engage with the action plan. These are both elements which the Procedures and Protocols for this MARAC state should be taking place.
 - The failure to record as a crime the disclosure of an historical stabbing made by Ben at the time of his arrest and shortly before his death, contrary to National Crime Recording Standards, and the failure to complete a VPRF1 and risk assessment of Ben following this disclosure was contrary to Merseyside Police Policy. It stopped this information being shared

amongst MARAC partners and prevented the safety of Ben being fully risk assessed.

- The Schools failure to follow up completion of the CAF forms prevented those concerns being followed up and monitored via Child In Need procedures. With the result that no family action meetings had been convened, and there was no plan of intervention in place.
- 8.15 It is recommended that compliance with policy forms a key part of the supervision of domestic abuse within single agencies and at future MARAC, DVIC meetings. Additionally, these key policies should be an integral part of the re-training of MARAC, and DVIC Chairs and meeting participants.
- 8.16 Whilst marketing of services for survivors of domestic abuse is widespread amongst agencies in St Helens, this Review could find no evidence of advice and guidance for friends and family members of victims who are aware that domestic abuse is taking place within the relationship and the importance of them seeking help in such cases. Included within this is the need to reinforce the variety of ways in which help and support for victims of domestic abuse can be obtained.
- 8.17 The final recommendation of this panel is for the Community Safety Partnership, Children's Services and the Safeguarding Boards to develop a joint education and awareness program focussed upon the family and friends of victims who are aware of ongoing domestic abuse and the need for them to take action in such instances alerting them to the many routes through which this disclosure can be made.

Individual Agency Action Plans.

9.1 The following actions have been identified as necessary to resolve weaknesses identified within individual agency IMR's.

Merseyside Police

9.2. When a victim calls the Police to report a 'domestic abuse' incident and states that violence has taken place, and then refutes this on the arrival of a patrol, the reporting officer must ensure that there has been no undue influence placed on the reporting party to change their story. The reason for any such change in the circumstances of an incident should be recorded on the VPRF 1 and considered during the risk assessment.

- 9.3 Some work has already been undertaken in respect of this action. Merseyside Police are currently developing a 'Bluestar' application for the Calls and response operators to ensure that all systems are checked upon deployment of a first responder so the risk is assessed appropriately. The content of the "Storm" log should be provided to the officer and the officer's responsibility to check the content and verify the information. All first responders now have personal laptops issued to them to allow them to check force systems. There is clear training and guidance for officers with regard the action they should undertake at the scene of a Domestic Incident and the subsequent completion of a VPRF/1 form. The new automated form will also provide an automatic aide memoire for officers to assist in completing the form and securing and verifying information at scene, including the Storm log. The new Coercion and Control lesson plan has incorporated the above issue and is aimed at all first responders across the organisation guiding the officer practically through this type of scenario.
- 9.4 If an allegation is made by a person involved in domestic conflict with another, that a knife or other deadly weapon was in the possession of, or used by that other, whether current or historical, then a VPRF 1 must be completed and an assessment of the risk to those involved undertaken.
- 9.5 Some work has already been undertaken in respect of this action. Merseyside Police record the use of weapons per se in any domestic incident, and clarify whether this is a pre-meditated weapon or an opportunity weapon through the MeRIT risk assessment. Continued guidance for officers is provided in the training which has been developed for Coercion and Control. This is to remind officers that historical incidents can often determine the risk level when deployed to current incidents and allow a wider referral for support from partner agencies. Merseyside Police are in discussion with Dr Keri Nixon with regard the most appropriate process within the VPRF1 form for the first responder to record and risk assess incidents involving knives to establish the most appropriate risk level and intervention.
- 9.6 When creating and indexing Niche logs or records, the perpetual abuse of alcohol by any of the parties involved should be highlighted on their PROtect record as a warning sign, even if the person is a victim.
- 9.7 Some work has already been undertaken in respect of this action. Merseyside Police record the presence of alcohol for both the victim and perpetrator when attending an incident of Domestic Violence, the use of a flagging system via Niche has been proposed to alert the officer and risk assessor of alcohol presence in any domestic incident. The opportunity to refer victims voluntarily to alcohol services or making applications for alcohol treatment orders for perpetrators charged with offences has been promoted.

This has been considered in conjunction with the Domestic Abuse Risk Assessment process conducted by the Domestic Violence Risk Assessor who research the incident and nominal and make the office in charge aware to allow applications for a treatment order in the case of a perpetrator to be included in any Crown Prosecution Service file. This includes their use of alcohol in previous incidents, if alcohol was present previously then domestic violence risk assessor can use professional judgement and consider raising the level of risk to allow alcohol intervention services to be utilised. Although referral to alcohol treatment services is a minimum intervention for incidents risk assessed as silver, there is no requirement to raise the risk level to silver for this intervention to be put in place. Bronze incidents – where alcohol is recognised as a risk indicator – can remain as bronze, but using professional judgement, a referral made to alcohol treatment services. Section 13.10.4 in the Merseyside Police Domestic Abuse Policy refers.

Children's Services

- 9.8 Assessments need to take full account of historical information and ensure it is fully reflected within the assessment process and during the formulation of plans.
- 9.9 Social workers need to reflect on the cumulative impact of a series of individual incidents contained within chronologies and not respond to and view them as a repeat/recurring series of unconnected incidents.
- 9.10 A management process to be developed to monitor service user engagement when they are referred to support services such as Addaction, the HELP Project or Freedom Project as part of an intervention plan. The purpose will be to determine if engagement (or otherwise) improves outcomes for children and/or provides evidence of non-compliance (disguised).
- 9.11 A common assessment should link to a plan of intervention that is subject to regular multi-agency review.
- 9.12 Assessments need to be rigorous in determining the extent of which individuals are victims and/or perpetrators of domestic violence.
- 9.13 The voice of the child should be clearly heard and reflected in all social work children and families assessments encompassing both direct input but also any consistent deficiencies in parenting.

- 9.14 Assessments plans and monitoring arrangements need to take account of the potential for disguised non-compliance of service users and the impact of this on outcomes for the child.
- 9.15 That DVIC be reviewed to consider whether appropriate assessment and mechanisms are put in place that address children at risk.

Community Safety Partnership

- 9.16 That the MARAC is provided with full disclosure by all agencies concerning perceived victims and perpetrators.
- 9.17 That the MARAC consider and document support available to both victim and perpetrator where alcohol abuse is prevalent.
- 9.18 That the MARAC question and document their considerations when counter allegations are evident.

St Helens and Knowsley Teaching Hospitals NHS Trust Acute Hospital/District General Hospital.

- 9.19 Use of this case to address learning in a multi-agency setting to include; Emergency Department, Alcohol Services, Mental Health Liaison, Domestic Abuse and Safeguarding Leads with an emphasis on developing skills in
- Accurate social history taking
- Identifying the hidden males.
- 9.20 Review advice/pathways in place relating to alcohol related attendances/admissions.
- 9.21 Review advice/pathways in place relating to bereavement issues
- 9.22 Review advice/pathways in place relating to substance misuse issues.
- 9.23 Audit the current use of electronic alerts to Domestic Abuse and Safeguarding Children.

Bridgewater Community Healthcare NHS Foundation Trust.

9.24 Conduct an audit of the use of MeRIT risk assessment checklist for domestic abuse by the Health Visiting, School Nursing and Family Nurse Partnership

Services. In order to establish if victims and their children are being reassessed in terms of risk being reduced or elevated.

Public Health

- 9.25 A training needs analysis to be undertaken in relation to alcohol awareness and effects on parenting/hidden harms across Police, Children's and Adult Social Care, G.P.'s MARAC and DVIC staff.
- 9.26 Public Health will ensure that reducing harm to children from parental problem drug and alcohol use is a priority aim of the Borough's Alcohol Strategy 2016 2017 onwards.
- 9.27 Terms of reference for DVIC and MARAC should include identifying alcohol and drug related challenges especially where there is evidence of or the potential for compromised parenting and take action to address that challenge.
- 9.28 All schools should identify at least one trained designated person able to deal with the problems that might arise with the children of problem drug users (Hidden Harms, 2003).
- 9.29 All services should ensure that the voices of the children of problem drug users are heard and listened to. Work is required to develop means of enabling the children of problem drug users safely to express their thoughts and feelings about their circumstances.
- 9.30 Public Health will explore the Borough offer in relation to providing appropriate support for the children of parents with drug and alcohol problems. Support should be available even if parents are unwilling or unable to change their use of drugs or alcohol.
- 9.31 Learning from this review should be cascaded to drug and alcohol treatment services who will consider when developing plans for the outreach elements of their service.

The family are placed in Universal visiting. Health visited last September (2013) to complete a pre-caf, following DV incident. Alison reported at the time Alison had been drinking 'home brew' with a friend and became confused and disorientated when he was drunk which resulted in the incident. She stated that Alison does not usually drink. Both parents live in the family home.
